



## EXCLUSIVE LIFETIME LABOR WARRANTY



Warrants to you, the purchaser, that the products covered by these warranties will be free from defects due to faulty workmanship for the lifetime of the products when the installation is performed in the manner specified and performed by Gutter Master. This Labor Warranty is limited to the exclusions, limitations, conditions and requirements and legal rights stated in this Warranty.

### EXCLUSIONS, LIMITATIONS, CONDITIONS

Warranty only covers gutters newly installed by Gutter Master, LLC. Purchaser must agree to an annual cleaning from Gutter Master, LLC, at the rate of \_\_\_\_\_ per cleaning \_\_\_\_\_ times per year. Warranty will become null and void if cleaning and or maintenance on the gutters has been performed by an outside entity other than those who are expressly permitted by Gutter Master in advance. This Warranty will also be null and void if the Cleaning Contract is not renewed bi-annually/annually (circle one) at a competitive cost. We exclude and are not responsible for any consequential or incidental damages arising out of any breach of this expressed Warranty or any other oral, written or implied Warranty that may apply to your purchases as it relates to our products.

### WARRANTY WILL NOT COVER

Warranty is limited to those gutters installed newly by Gutter Master and as listed on the cleaning contract. Cleanings on any gutters not newly installed or not listed on the contract will not be covered. If purchaser wishes to have a cleaning contract on other gutters not newly installed by Gutter Master, LLC, the gutters must first be inspected and approved by Gutter Master, LLC and an amendment to the original contract will then be put in place to add the additional cleaning.

### WARRANTY IS TRANSFERABLE

Warranty is transferable upon change of ownership of the property and or change of Management Company. To transfer this Warranty, you must send a copy of title transfer and a copy of the original Warranty Certificate within 30 days of title transfer along with a check or money order in the amount of \$50.00 to cover cost of transfer.

### TO INITIATE A CLAIM

To initiate a claim, you should contact Gutter Master, LLC for service and resolution within a reasonable period of time after the defect is discovered. To submit a written claim, please provide the following information: a copy of the original Warranty form, a description of the claimed defect and the date defect was discovered. **Send to Gutter Master LLC, 14 Twin Oaks Court, Jackson, NJ 08527. You can also call the office at 732-833-8844 and we will schedule an appointment to inspect the claim. Due to normal weathering, the replacement product may differ from that which was originally installed. Gutter Master LLC will work with you in such case to choose the right color product for you.**

### WARRANTY ACTIVATION

To activate this Warranty, the original purchaser must fill out, sign and mail in the registration within 30 days of installation date.
